<u>Deadline</u> ** for receipt of appellants' additional evidence/information	5 working days before date of hearing	** IMPORTANT: Where full grounds, additional evidence / information is received <u>after this deadline</u> , the Panel must decide (at start of hearing) whether any of this information is to be considered, taking into account its significance and the effect of a possible need to adjourn the hearing. To be certain all information / evidence is taken into account, it must be received by the specified deadline!

Short decision letter sent	Within 1 working day of decision being made	
Full decision letter (with reasons) sent	Within 5 working days of decision being made but, e.g. where several appeals for same school, this may be extended to 20 working days
